**CALL TO ORDER:** President Wagle called the meeting to order at 6:00 p.m.

**AGENDA APPROVED:** Motion by Ayers, second by Kunkel that the agenda be approved as presented. All ayes. Motion carried.

**COMMUNICATIONS:** President Wagle welcomed everyone to the meeting and read the vision of the District: It is the vision of the Pleasant Valley Community School District that we shall provide the finest academic and extra-curricular programs in the state – not in some things, but in everything; not for some students, but for every student.

Director Smith complimented PVHS art students on their recent pottery display.

**ESTABLISH NEW BOARD POLICY REGARDING SOLVENCY RATIO:** As part of the high school expansion and renovation project and borrowing against future SAVE (Secure an Advanced Vision for Education) revenues, the District recommends adopting two board policies addressing the use of funds in keeping with the District's vision, mission and goals. Policies 810.01 and 810.01R1 outline how the district will engage the board in learning the financial needs, operations and requirements of the district as appropriate for the board's understanding of the district financial position. The policies were first presented to the board on February 12, 2024 and a second reading was held February 26. A final reading was held and a motion for approval presented this evening.

Motion by Kanwischer, second by Ayers that the board approve the additions to board policy series 800 addressing the use of District funds as presented. Roll call vote. Ayes - Ayers, Brockmann, Kanwischer, Kunkel, Smith, Wheeler, Wagle. Nays - none. Motion carried.



**PLAYGROUND BIDS:** At the February 12, 2024 meeting, the Board approved the elementary playground project documents (plans and estimates) as presented by IMEG Engineering Consultants. This initial round of playground reconstruction will occur at Bridgeview, Pleasant View and Riverdale Heights Elementary buildings. The bid opening took place on Thursday, March 7th at 2:00 pm. After vetting seven companies and inviting three to bid, one bid was received from All American Concrete / Cunningham Recreation for \$1,372,000.00. The final bid came in below estimated cost and the district has full confidence in the successful bidder. After discussion of the project, President Wagle opened the required Public Hearing at 6:26 p.m. Hearing no comments from the public, the hearing was closed at 6:27 p.m. and a motion was received.

Motion by Ayers, second by Kanwischer that the board approve the low bid from All American Concrete / Cunningham Recreation for \$1,372,000.00 for the 2024 Playground Replacement Project. Roll call vote. Ayes - Ayers, Brockmann, Kanwischer, Kunkel, Smith, Wheeler, Wagle. Nays - none. Motion carried.

**ELEMENTARY, JUNIOR HIGH AND HIGH SCHOOL HANDBOOKS:** High School Associate Principal Jason Jones, Junior High Dean of Students Tia Hicks, and Director of Elementary Education Tony Hiatt described to the board updates to the 2024-25 student/parent handbooks. The board reviewed a summary of the updates. When practical, goals include vertical alignment between levels and updating language to coincide with current practice. When 2024-25 online registration is completed for students later in the spring, parents/guardians will be asked to confirm that they have reviewed the student/parent handbook.

**RESOLUTION FIXING THE DATE OF SALE, APPROVING ELECTRONIC BIDDING PROCEDURES AND APPROVING OFFICIAL STATEMENT:** Mr. Clingingsmith reviewed with the board documents related to the issuance of PVCSD School Infrastructure Sales, Services and Use Tax Revenue Bonds, Series 2024. Board members were previously presented a copy of the Preliminary Official Statement for their review. The Preliminary Official Statement was prepared and reviewed by our Financial Advisors at Piper Sandler & Co. and reviewed by our Bond Counsel (Ahlers & Cooney Law Firm), and by the Superintendent and Chief Financial Officer prior to presentation to board members.

Passage of the resolution accomplishes the following:

- Sets April 8, 2024 at 11:00 a.m. as the date and time for the sale of the bonds
- Approval of the use of the PARITY Competitive Bidding System and Electronic Bidding Procedures to facilitate the delivery of the bids
- Approval of the Preliminary Official Statement (POS) and authorization of its distribution

Motion by Wheeler, second by Ayers that the Board approve the Resolution Fixing the Date of Sale, Approving Electronic Bidding Procedures and Approving Official Statement as presented. Roll Call Vote. Ayes - Ayers, Brockmann, Kanwischer, Kunkel, Smith, Wheeler, Wagle. Nays - none. Motion carried.

**2023-24 CERTIFIED BUDGET AMENDMENT PRESENTATION AND PUBLIC HEARING:** Mike Clingingsmith reviewed the proposed budget amendment and supplemental information for 2023-24. Amendment of the certified budget is a routine procedure which is normally done annually. The main reasons for amendment are to reflect the actual spending of miscellaneous income received during the year (which was not included in the original certified budget) and to reflect the spending of all district fund balances down to zero at the end of the fiscal year. By amending the budget in this manner, the budget reflects the maximum expenditures which could possibly be incurred and paid during the fiscal year. It is very unlikely that those maximum amounts will actually be incurred.

Per Section 257.7 of the Iowa Code, the authorized expenditures of a school district may not exceed the lesser of:

- the certified budget plus any amendments for the fiscal year or
- the district's total authorized spending authority for the year which includes
  - the combined district cost for that year
  - the actual miscellaneous income received for that year, and
  - the actual unspent balance from the preceding year.

After discussion of the procedure, President Wagle opened the required Public Hearing at 7:00 p.m. Hearing no comments from the public, the hearing was closed at 7:01 p.m. and a motion was received.

Motion by Kanwischer, second by Brockmann that the Board amend the 2023-24 budget as adopted on April 24, 2023 by changing estimates of expenditures as presented in the notice of public hearing for amendment of current budget for 2023-24. Roll call vote. Ayes - Ayers, Brockmann, Kanwischer, Kunkel, Smith, Wheeler, Wagle. Nays - none. Motion carried.

**MEETING ADJOURNED:** The meeting adjourned at 7:09 p.m.


### **NOTICE OF NONDISCRIMINATION**

**COOPERATIVE AGREEMENT**  
**by and between**  
**UNIVERSITY OF NORTHERN IOWA and COOPERATING EDUCATIONAL AGENCIES**  
**for the 2024-2025 Academic Year**

This agreement entered into by and between the Board of Regents, State of Iowa, the governing body of the University of Northern Iowa, and **Pleasant Valley Community School District** (hereinafter referred to as the “cooperating educational agency”), in accordance with the Code of Iowa:

**Section 262.30 CONTRACTS FOR PRACTITIONER PREPARATION provides:**

The board of directors of any school district in the state of Iowa may enter into contract with the state board of regents for furnishing instruction to pupils of such school district, and for practitioner preparation for the schools of the state in such particular lines of demonstration and instruction as are deemed necessary for the efficiency of the University of Northern Iowa ... as training schools for practitioners.

AND see also **Section 256.16(1)(m)**.

**1. Scope of Agreement**

- 1.1** This Agreement sets forth the roles, responsibilities, and rights of personnel associated with the cooperating educational agency, personnel associated with the University of Northern Iowa and of any student enrolled at the university, while assigned as a student teacher or for any other educational experience in the cooperating educational agency.

**2. Options of Student Teachers and other Educational Experience Students**

- 2.1** Students must be registered for the appropriate university course. Student teaching is a full semester experience. (Students seeking additional endorsement may register for four (4) hours of credit.) The student teaching period will be a minimum of 14 weeks in duration.

**3. Placement of Students**

- 3.1** Placement of students shall be accomplished on a cooperative basis between the University of Northern Iowa and the cooperating educational agency. All participating UNI students have completed a background check, including criminal background and child abuse, sex abuse, and dependent adult abuse registry checks, before beginning their field experience.
- 3.2** Placement shall be initiated by the university coordinator (hereinafter referred to as coordinator) upon completion of an application from each student setting out the student’s qualifications/background and the assignment(s) needed to meet course requirements, certification, endorsement, and approval area standards.
- 3.3** Requests for assignment of students may be accompanied by suggested names of individuals who are recommended to serve as a cooperating teacher/educational agency supervisor by the coordinator.
- 3.4** The University of Northern Iowa reserves the right to decline the assignment of a student to classroom teachers/educational agency supervisors who may request a student. However, said decision shall not be based on race, creed, color, sex, national origin, disability, age, religion, gender identity, sexual orientation, veteran or military status or on any other basis protected by state and/or federal law.
- 3.5** The cooperating educational agency reserves the right to refuse assignment to any given student. However, said decision shall not be based on race, creed, color, sex, national origin, disability, age, religion, gender identity, sexual orientation, veteran or military status or on any other basis protected by state and/or federal law.

**4. Termination or Change of Assignment**

- 4.1** The coordinator or cooperating educational agency may, for good cause, terminate or change the assignment of any student. Prior to reaching a decision the coordinator and the cooperating educational agency designee shall consult with the cooperating teacher/educational agency supervisor and all other concerned parties regarding the reason(s) for termination or change in assignment. If the district desires to terminate or change and assignment, the student will not return to the District Facility while awaiting the required consultation before the termination/change of assignment.

**5. Supervision of Students**

- 5.1** A member of the university faculty, or designee, will serve as the coordinator or supervisor of the student teaching program or educational experiences for the purpose of administering the program and supervising/evaluating the students in cooperation with the cooperating teachers/educational agency supervisors who guide and direct the students.
- 5.2** The identification, selection and continued use of qualified cooperating teachers/educational agency supervisors shall be the joint responsibility of the coordinator and the administrators of the cooperating educational agencies.

- 5.3 The students shall be subject to the policies, rules and regulations of the cooperating educational agency, UNI Office of Student Field Experiences, University of Northern Iowa and the Professional Code of Ethics.
- 5.4 All interaction between the cooperating teacher/educational agency supervisor or nonpublic cooperating educational agency and the student shall occur without regard to religious education, religious indoctrination, religious beliefs, or involvement with religious activities. Students shall not be present or participate in the instruction or discussion of religious subjects or any other religious activity of the cooperating educational agency.

**6. Evaluation**

- 6.1 Evaluation of the students shall be a shared responsibility. The coordinator or supervisor, the cooperating teacher/educational agency supervisor, the student, and others knowledgeable about the performance of the student shall be involved. Evaluation is comprehensive, continuous, specific, and individualized. The evaluation in the nonpublic educational agency shall be based on non-religious criteria.
- 6.2 Mid-term and final evaluation conferences are required of student teachers. The student teacher, cooperating teacher, and coordinator or supervisor shall participate. The cooperating teacher(s) and coordinator or supervisor shall collaborate in the preparation of the final evaluation for each student. However, the coordinator, as the designated UNI official, is responsible for the final evaluation.

**7. Status, Authority, and Tort Liability Protection of Students**

- 7.1 Students shall have status and authority in accordance with section 256.16 Code of Iowa.
- 7.2 Students actually engaged under the terms of this contract in a public school shall be entitled to the same tort liability protection under the provisions of section 670.8 Code of Iowa, as is afforded by said section to officers and employees of the school district/agency during the time they are so assigned.
- 7.3 Students actually engaged under the terms of this contract in a non-public school shall be named as additional insured under the liability insurance coverage of the cooperating nonpublic school during the time they are so assigned. The cooperating nonpublic school shall provide a certificate of insurance to the University of Northern Iowa as evidence of such coverage prior to the beginning of the student teacher’s activities pursuant to this agreement.


**8. Substitute Teaching**


- 8.1 Students are allowed to substitute teach if they hold a substitute authorization license if certain requirements are met. It is the responsibility of the UNI Faculty Coordinator to ensure the student is meeting the minimum requirements for student teaching with the Iowa BOEE for their initial teaching license. Time spent as a substitute teacher does not count toward the minimum requirement of student teaching.

**9. Compensation to Cooperating Teachers for Work with Student Teachers**

- 9.1 The University of Northern Iowa agrees to pay compensation to the cooperating teacher (262.75 Code of Iowa) in the amount of four-hundred dollars (\$400) per student teacher assigned who completes the full semester student teaching period. Assignment of less than a full semester will be compensated on a prorated basis for a cooperating teacher’s work with a student teacher.
- 9.2 For student teacher placements, cooperating educational agencies agree to provide a listing of the cooperating teachers assigned in their district and to forward social security numbers when direct payment is made to cooperating teachers OR allow the University of Northern Iowa to request from the individual cooperating teachers their social security number and home address for direct payment to cooperating teachers.

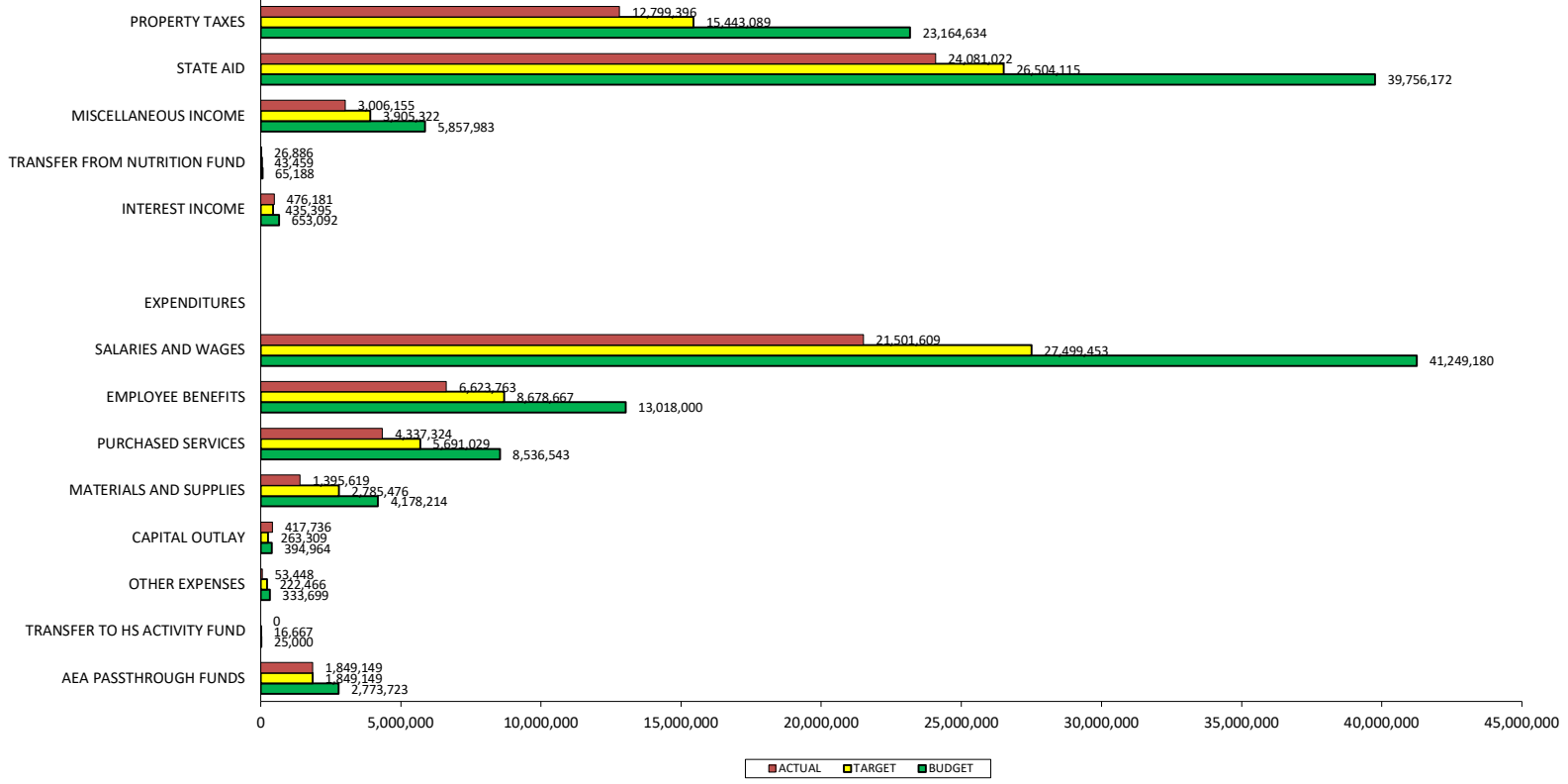

## Personal Day Carry Over

- Carry over up to 2 days to the next year
- Days that can't be carried over can be converted to sick days
- Eliminate borrowing from previous year
- Personal Leave to extend a long weekend or break will be considered for approval if 97% 3 yr avg or as unpaid

- Allows for flexibility in use of personal days
- Allows for staff to accrue additional sick time for unused personal days

## Family Illness Leave

- Non-Critical (6) and Critical (9) days become a bank of Family Illness Leave (10)
- Separate leave (2) for bereavement
- Adoption/foster leave comes from unused Family Illness Leave (up to 120)

- Simplifies the leave banks
- Allows for 4 additional non-critical and 1 additional critical day to be used in a school year
- Maintains adoption/foster leave

## Early Retirement Qualifier

- \*Certified to receive the full benefit (50% of last year salary over 2 years), must have equal the number of sick days to 1 contract year (194 days)
- If less than 1 contract year the benefit will be proportional amount

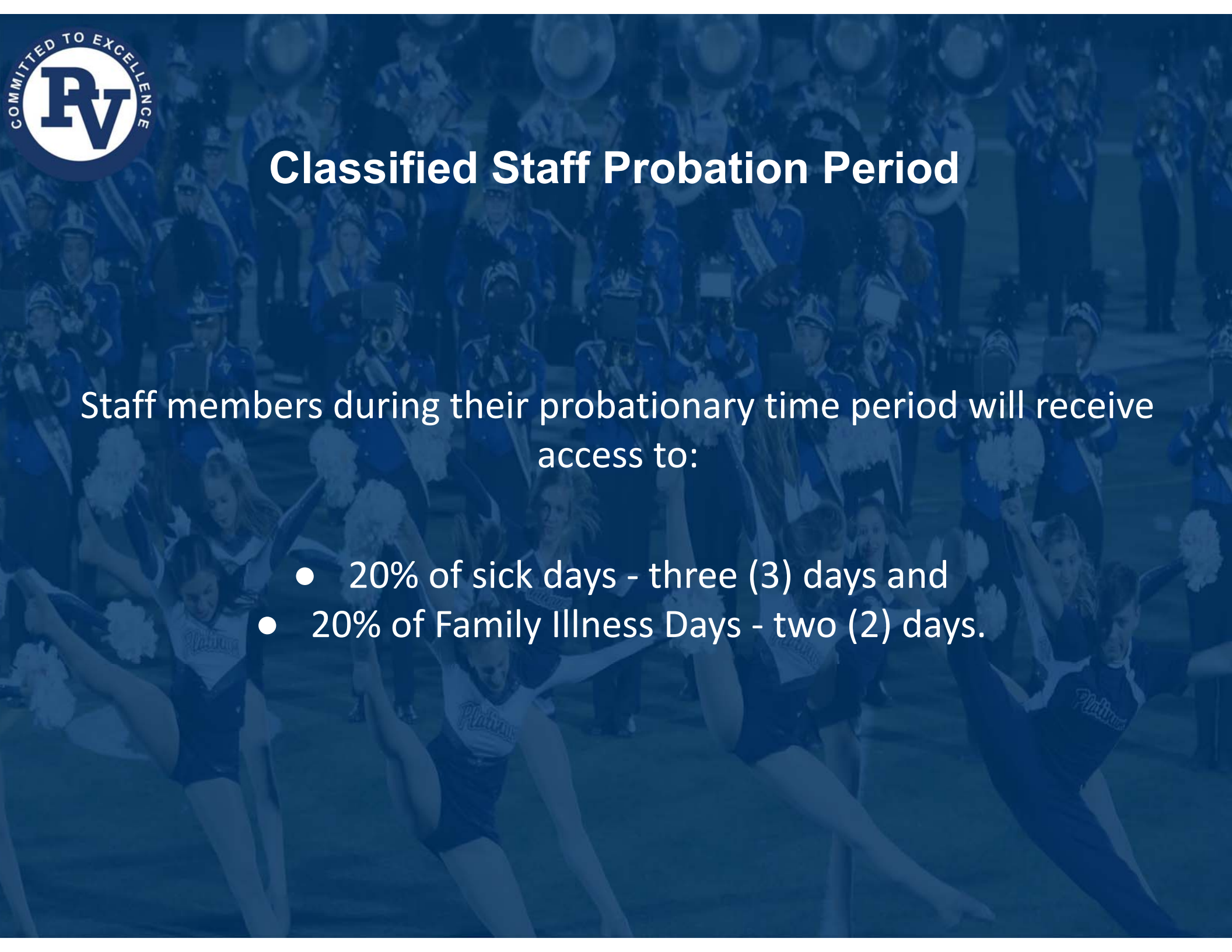
